This end user license agreement (hereafter ›agreement‹) is a legal agreement between you, or, if you represent a legal entity, that legal entity (hereafter ›you‹) and Jan Henrik Arnold (hereafter ›JHA‹). By downloading and/or installing JHA font software (hereafter ›font‹) you acknowledge that you have read, understood, and agreed to be bound by the terms and conditions of this license agreement.

1. DESKTOP FONT LICENSE

JHA gives you the right to use the enclosed font on one (1) computer or workstation at a single geographic location and on one (1) portable device such as a notebook or laptop computer. These computers can be connected to any number of output devices, such as laser printers, ink jet printers, an image setter or a film recorder. This means only one (1) user is allowed to use the license. You need a written license extension to exceed the number of computers and locations. Foundry reserves all rights not expressly granted to you in this agreement.

2. RESTRICTIONS OF USE

(i) You may embed the JHA font into documents, applications or devices either as a rasterised representation of the font (eg: .jpg, .gif, .png or .tif) or as a subset of the font as long as the document, application or device is distributed in a secure format that permits only the viewing and printing but not the editing of the text or changes of the layout.

(ii) You need another license (font software broadcast license) for displaying the font in cinemas, motion pictures, games, on television or cable television, streaming services or streaming sides in titles, subtitles or other prominent graphical output. (iii) This license does not permit the transmitting of the font over the internet in font serving or for font replacement by means of technologies such as, but not limited to: eot, cufon, sIFR, typeface.js, woff, woff2 or other technologies that now exist or may be developed in the future.

3. COPYRIGHT

The font and the design are in their form, structure and code exclusive property of JHA. No ownership rights are granted as a part of this contract. This font is protected by the United States Copyright Law and design laws by nations and international treaties. You agree to treat the font as confidential information and exercise reasonable care to avoid unauthorised distribution. You may make back-up copies of the font for archival purposes only, provided that you retain exclusive custody and control over such copies.

4. ALTERATIONS OF THE FONT

Except as the granted back-up you may not copy, modify, adapt, convert, translate, reverse engineer, decompile, disassemble, alter, or attempt to discover the source code of the font software. If you intend to make alterations to the font, you must obtain the prior written consent of JHA. If the font contains embedding bits that indicate that the font software is only authorized for certain purposes, you may not change or alter the embedding bits.

5. WARRANTY

JHA warrants that the font will perform as it should for the thirty (30) day period following your receipt. To make a warranty claim, you must return the font along with a copy of your sales receipt within the thirty (30) day period. If the font does not perform correctly, JHA or you will either replace the font or refund the license fee you paid for the font. JHA does not and cannot warrant the performance or results you may obtain by using the font. In no event will JHA be liable to you for any consequential incidental or special damages, including any lost profits or lost savings.
