This end user license agreement (hereafter ›agreement‹) is a legal agreement between you, or, if you represent a legal entity, that legal entity (hereafter ›you‹) and Jan Henrik Arnold (hereafter ›JHA‹). By downloading and/or installing JHA web font software (hereafter ›font‹) you acknowledge that you have read, understood, and agreed to be bound by the terms and conditions of this license agreement.

#### 1. WEB FONT LICENSE

The font is licensed, not sold, to you for use only under the terms of this agreement. You are hereby granted a non-exclusive, non-assignable, non-transferable (except as expressly permitted herein) license to use the licensed web font on one (1) specified domain and three subdomains (3), using the @font-face selector in CSS files subject to the next section. Foundry reserves all rights not expressly granted to you in this agreement.

#### 2. RESTRICTIONS OF USE

(i) You may not link to, nor put online, any version of a font not supplied in a web font kit or file format. The comments, showing copyright and other legal information provided in the sample HTML/CSS/javascript files, for each font must be retained in your working website code.

(ii) The total traffic, measured in page views, of all websites using a font must be no greater than the number of page views specified in your agreement.

(iii) Businesses or organisations such as advertising agencies, web design agencies or hosting providers that are responsible for multiple clients' websites must enter into separate agreement's for each client website.

(iv) The font may be used in a website where visitors produce styled content by directly or indirectly selecting a font and entering or editing content using that font, if and only if the website does not enable or facilitate the styled content being used outside the website. Examples of using styled content outside of a website include but are not limited to producing merchandise, .pdf documents, image files, or personalized physical objects using the styled content or opening the website through an application.

(v) You may not use conversion or editing tools on the font or technologies other than @font-face or .woff and .woff2 files, such as sIFR, cufon or typeface.js. You need a written license extension to use other technologies.

#### 3. COPYRIGHT

The font and the design are in their form, structure and code exclusive property of JHA. No ownership rights are granted as a part of this contract. This font is protected by the United States Copyright Law and design laws by nations and international treaties. You agree to treat the font as confidential information and exercise reasonable care to avoid unauthorised distribution. You may make back-up copies of the font for archival purposes only, provided that you retain exclusive custody and control over such copies.

#### 4. ALTERATIONS OF THE FONT

Except as the granted back-up you may not copy, modify, adapt, convert, translate, reverse engineer, decompile, disassemble, alter, or attempt to discover the source code of the font software. If you intend to make alterations to the font, you must obtain the prior written consent of JHA. If the font contains embedding bits that indicate that the font software is only authorized for certain purposes, you may not change or alter the embedding bits.

#### 5. CREDITS FOR THE FONT

You shall identify the fonts to visitors of websites only by the font's original name and in accordance with accepted trademark practice, including identification of the trademark owner's name. #### 6. WARRANTY

JHA warrants that the font will perform as it should for the thirty (30) day period following your receipt. To make a warranty claim, you must return the font along with a copy of your sales receipt within the thirty (30) day period. If the font does not perform correctly, JHA or you will either replace the font or refund the license fee you paid for the font. JHA does not and cannot warrant the performance or results you may obtain by using the font. In no event will JHA be liable to you for any consequential incidental or special damages, including any lost profits or lost savings.

#### 7. TRANSFER OF THE FONT

You may not rent, lease, sublicense, give, lend, or further distribute the font(s), or any copy thereof, except as expressly provided herein. You may transfer all its rights to use the licensed font(s) to another person or legal entity provided that the transferee accepts and agrees to be bound by all the terms and conditions of this agreement, and you destroy all copies of the font(s), including all copies stored in the memory of a hardware device. If you are a business or organisation, you agree that in case of a reasonable doubt with regard to the proper use of the font(s) within your organisation, upon request from JHA or its authorized representative, you will, within thirty (30) days, fully document and certify that the use of any and the font licensed by you from JHA at the time of the request is in conformity with your valid licenses from JHA.

#### 8. TERMINATION / GENERAL PROVISIONS

The license granted herein is effective with the full payment until terminated. JHA has the right to terminate your license immediately if you fail to comply with any term of this Agreement. Upon termination, you must destroy the original and any copies of the font and documentation. The JHA Font Software Web License Agreement is subject to German Law. If any part of this agreement is found void and unenforceable, it will not affect the validity of the agreement, which shall remain valid and enforceable according to its terms.
